
**ORDER**

AND NOW, this 25<sup>th</sup> day of January, 2019, it is hereby ORDERED

as follows:

1. The Mirena Settlement's Master Settlement Agreement between the Plaintiffs, (MDL; New Jersey; California and St. Louis), and Bayer HealthCare Pharmaceuticals, Inc., Bayer Oy and Bayer Pharma AG, (Bayer Defendants), appointed this Honorable Court to enforce the terms of the Mirena Settlement.
2. The Court understands that the parties are very close to finalizing the terms of the Mirena Settlement and, if finalized, funding can then occur shortly thereafter. In order for funding to occur, the parties and the Lien Resolution Administrator, (The Garretson Resolution Group), need to determine Medicare eligibility for each participating claimant.
3. So that this Mirena Settlement can be finalized and funding can occur, this Case Management Order requires the following:
  - a. By 5:00 P.M. EST on February 7, 2019, counsel of record for any Mirena claimant who has enrolled in the Mirena Settlement Program must complete the tasks set forth in the attached Exhibit "A".
4. If any claimant participating in the settlement fails to upload the required information to the Garretson secure portal by the February 7, 2019 deadline, the Court shall consider all available remedies, including the dismissal of such action.

## EXHIBIT A

Each claimant who has not yet submitted data to Garretson Resolution Group (hereinafter "GRG") for all participating Mirena claimants, must do so via the Garretson's Mirena IUD Consolidated Settlement website. Instructions for how to access the site and upload claimant data are provided below.

Data for all participating claimants *must be uploaded to the GRG Mirena Webpage by no later than 5:00 PM on Thursday, February 7, 2019*. Cases for which data is not received by this date will be in jeopardy of being dismissed as this data is *required* to move forward with the settlement. Please **DO NOT** change or re-submit data that you have already submitted to GRG regarding your claimant(s).

Please fill out the claimant data template as completely and thoroughly as possible. It is *absolutely crucial* that GRG receives the following data points for each participating claimant to be able to move forward with the settlement:

- *first and last name,*
- *full Social Security Number (not just last four digits),*
- *date of birth,*
- *current state of residency,*
- *First Event Date (i.e. the date that the Mirena IUD was implanted), and*
- *Removal Date (i.e. the date that the Mirena IUD was removed).*

### Instructions for submitting claimant data via GRG's Mirena IUD Consolidated Settlement website:

Step 1: Access the program page at <https://web.garretsongroup.com/mirena>.

Step 2: Click the "Download Mirena Data Template" button to copy the Mirena data template to your computer.

Step 3: Enter the claimant information into the template and save the completed file to your computer.

Step 4: Return to the website and click the "Submit Mirena File" button to upload the file to GRG.

Note: Please do **not** rename, move or delete the columns in the claimant data template.
