CASE MANAGEMENT

- 1. Defendants shall continue to provide to Plaintiffs each month a list of Plaintiffs who have failed to timely serve Fact Sheets pursuant to CMO #3 and on which the Defendants intend to file Motions to Dismiss. Plaintiffs shall file a Fact Sheet or seek an extension at least two days prior to the Motion Filing Date. If not, Defendants have leave to file a Motion to Dismiss without prejudice, pursuant to CMO #3. Defendants shall file one omnibus motion (with a fee and order for every docket number it applies to). This motion will be returnable on the dates so indicated.
- 2. Counsel shall continue to meet and confer regarding the Second Disposition Pool and shall submit a proposed Order to the Court with the next Agenda.
