2. The above-named SDP Plaintiffs are hereby granted leave to file amended complaints consistent with this and other orders of this Court. The deadline to do so shall be September 3, 2015.



3. Any plaintiff whose action is subsequently selected for the SDP as a replacement case shall have thirty days from the date of selection to file an amended complaint.

4. SDP complaints filed and served upon Bayer Healthcare Pharmaceuticals, Inc., prior to February 26, 2014, may be amended pursuant to Order No. 14 for the purpose of adding Defendants Bayer OY and Bayer Pharma. Any such amendment must be completed by September 3, 2015. Service of amended complaints on Bayer OY and Bayer Pharma AG shall be effected in accordance with the ORDER REGARDING PROPER-PARTY DEFENDANT AND ABBREVIATED SERVICE PROCEDURES FOR SERVICE UPON BAYER HEALTHCARE PHARMACEUTICALS INC. dated August 12, 2013 and the FIRST AMENDED ORDER REGARDING PROPER-PARTY DEFENDANT AND ABBREVIATED SERVICE PROCEDURES FOR SERVICE UPON BAYER HEALTHCARE PHARMACEUTICALS INC., BAYER OY and BAYER PHARMA AG dated February 25, 2014.

5. Defendants shall have until November 2, 2015 to answer the SDP Plaintiffs' amended complaints (or complaints, in the case of any SDP Plaintiff who does not file an amended complaint).

6. In the case of any plaintiff in this MCL whose action is subsequently selected for the SDP as a replacement case, Defendants shall have thirty days from the date of that plaintiff's filing of an amended complaint to file an answer. For any plaintiff whose action is selected as a replacement SDP case and who does not amend her complaint, Defendants shall have sixty days from the date of the selection of that action for the SDP to file an answer to the plaintiff's complaint.
