#### CASE MANAGEMENT

1. Defendants shall continue to provide to Plaintiffs each month a list of Plaintiffs who have failed to timely serve Fact Sheets pursuant to CMO #3 and which the Defendants may file Motions to Dismiss. Plaintiffs shall file a Fact Sheet or seek an extension at least two days prior to the Motion Filing Date. If not, Defendants have leave to file a Motion to Dismiss without prejudice, pursuant to CMO #3. Defendants shall file one omnibus motion (with a fee and order for every docket number it applies to). This motion will be returnable on the dates so indicated.

- Parties have presented the Court with a Proposed Pretrial Scheduling Order.
   Counsel will meet and confer and submit a final order to the Court within two (2) days.
- 3. Over Defendants' objection, the Court will modify its prior Case Management Order #35 as follows: paragraph 12 is amended to require each side to select three (3) Second Disposition Pool cases on March 4, 2016; and each side shall exercise two (2) vetoes on March 11, 2016.

#### **GENERAL:**

- 4. The next Case Management Conference is scheduled for March 9, 2016, at 11:00 am. Liaison Counsel shall report at 10:30 am. Counsel shall submit a proposed agenda seven (7) days prior to this Case Management Conference. Conferences are also scheduled for the following dates: April 6, 2016, May 4, 2016 and June 8, 2016.
- 5. By consent of all parties, the Court may contact or be contacted on an *ex parte* basis regarding settlement issues <u>only</u>.
- 6. The Court may, from time to time, conduct phone conferences with defense counsel and liaison counsel.
- 7. Subject to agreement by and between counsel and with permission from the Court, counsel is permitted to appear telephonically; in order to have your appearance on the record, it is counsel's responsibility to e-mail liaison counsel and the court reporter at least one hour before the proceeding with your name,

- firm, and party representing, indicating that you intend to appear by phone; in addition you must confirm you appearance, immediately following the proceeding. Absent the above, counsel's appearance will not be noted.
- 8. The official record shall be the transcript provided by the court reporter retained by counsel. The reporter shall preserve all proceedings and shall email a transcript of any court proceeding to the court within 14 days of the proceeding.
- Counsel is permitted to serve one motion with a schedule of attached cases for pro
  hac admission. However, a separate order per case/docket number and filing fees
  is required.
- 10. The Court directs all counsel to <u>R</u>. 1:48 and expects all counsel to abide by the parameters set forth therein.
- 11. All Court proceedings will start at the designated scheduled time. Counsel is expected to arrive promptly for these proceedings.

- 13. Any such submission received after 4:30 p.m. will be deemed received at 9:00 a.m. on the next day Court is in session. Any such submission received after 4:30 p.m. on a Friday or over a weekend, will be deemed received on 9:00 a.m. on the next day Court is in session.
