# CASE MANAGEMENT

- Plaintiffs' counsel may respond to Defense counsel's submission of April 1, 2016 regarding Judge Seibel's <u>Daubert</u> Opinion and the applicability of the New Jersey <u>Kemp</u> standard by September 30, 2016. Defense counsel's reply shall be submitted no later than November 1, 2016. Plaintiffs' sur-reply shall be submitted by November 22, 2016. The date for oral argument will be set at the next Case Management Conference.
- The dates of future Case Management Conferences scheduled in Case Management Order No. 49 are hereby cancelled.
- 3. The pretrial deadlines under the Pretrial Scheduling Order filed February 12, 2016 remain suspended.
- 4. Deadlines for the Second Disposition Pool under Case Management Order No. 35 remain suspended.
- 5. Counsel shall meet and confer to develop a procedure addressing potential statute of limitations issues. A finalized procedure will be presented to the Court at the next Case Management Conference.

#### PART IV

#### **GENERAL**:

- 6. The next Case Management Conference is scheduled for September 29, 2016, at 11:00 am. Liaison Counsel shall report at 10:30 am. Counsel shall submit a proposed agenda seven (7) days prior to this Case Management Conference.
- By consent of all parties, the Court may contact or be contacted on an *ex parte* basis regarding settlement issues <u>only</u>.
- The Court may, from time to time, conduct phone conferences with defense counsel and liaison counsel.
- 9. Subject to agreement by and between counsel and with permission from the Court, counsel is permitted to appear telephonically; in order to have your appearance on the record, it is counsel's responsibility to e-mail liaison counsel and the court reporter at least one hour before the proceeding with your name, firm, and party representing, indicating that you intend to appear by phone; in addition you must confirm you appearance, immediately following the proceeding. Absent the above, counsel's appearance will not be noted.
- 10. The official record shall be the transcript provided by the court reporter retained by counsel. The reporter shall preserve all proceedings and shall email a transcript of any court proceeding to the court within 14 days of the proceeding.
- 11. Counsel is permitted to serve one motion with a schedule of attached cases for pro hac admission. However, a separate order per case/docket number and filing fees is required.

- 12. The Court directs all counsel to  $\underline{R}$ . 1:48 and expects all counsel to abide by the parameters set forth therein.
- 13. All Court proceedings will start at the designated scheduled time. Counsel is expected to arrive promptly for these proceedings.

- 15. Any such submission received after 4:30 p.m. will be deemed received at 9:00 a.m. on the next day Court is in session. Any such submission received after 4:30 p.m. on a Friday or over a weekend, will be deemed received on 9:00 a.m. on the next day Court is in session.
