CASE MANAGEMENT ORDER No. 55

AND NOW, this 9th day of April, 2018, it is

hereby ORDERED as follows:

1. On October 17, 2016, Case Management Order No. 51 was issued. CMO No. 51 required Defendant to provide a list of cases that it believes are time barred to the law firms associated with said clients by November 1, 2016.
2. For those law firms that received notice of any clients/cases that Defendant believes are time barred, CMO No. 51 required said law firm to respond with a detailed explanation why said case is not time barred by January 6, 2017.
3. Attached to this Order as Exhibit "A" is a list of cases in which law firms, after receiving the list of allegedly time barred cases from Defendant, advised Defendants in writing that said cases were time barred and could be dismissed.

4. Given Plaintiffs' agreement to dismiss those cases on Exhibit "A", this Court will dismiss, with prejudice, those cases on Exhibit "A" on **May 9, 2018 at 12:30 p.m.** unless counsel for any of the identified Plaintiffs appears before Judge Harz on **May 9, 2018 at 11:00 a.m.** in Courtroom 359 and shows cause why the Court should not issue the dismissal order.
