WHEREAS on February 28, 2020, the Court entered an Order requiring that counsel for plaintiffs identified in Schedule A attached to that Order provide evidence of implantation of a Bard-manufactured product to counsel for Defendant C. R. Bard, Inc., Melissa Geist, Esq. within thirty (30) days of the entry of that Order; and

WHEREAS the February 28, 2020 Order was served on Plaintiffs' Liaison Counsel, Adam Slater, Esq. and electronically served on counsel for Plaintiffs via Lexis Nexis File and Serve ("LNFS") on February 28, 2020;

WHEREAS Liaison counsel for Plaintiffs and Liaison counsel for Defendant C. R. Bard conferred in March 2020 and agreed that C. R. Bard was not going to seek dismissals due to the

evolving COVID-19 pandemic and agreed that a reasonable extension was warranted under the circumstances;

WHEREAS by letter dated May 7, 2020, the Court agreed to extend the deadline in the February 28, 2020 Order and ordered Plaintiffs identified in Schedule A to provide evidence of implantation of a Bard-manufactured product by June 8, 2020;

WHEREAS the May 7, 2020 letter was served on Plaintiffs' Liaison Counsel, Adam Slater, Esq. and electronically served on counsel for Plaintiffs via LNFS on May 7, 2020;

WHEREAS the June 8, 2020 deadline to provide evidence of implantation of a Bard-manufactured product has expired;

WHEREAS the plaintiffs identified in this Order have not provided evidence of implantation of a Bard-manufactured product to Melissa Geist, Esq.; and for good cause;

IT IS on this 12 day of June, 2020 ORDERED that counsel for plaintiffs identified below shall file a certification along with evidence by Friday, June 26, 2020 to show good cause to the satisfaction of the Court of why they did not comply with the prior Order and why Plaintiffs' complaints should not be dismissed with prejudice for failure to comply with the Court's February 28, 2020 Order and subsequent May 7, 2020 extension of time:
