ORDER DIRECTING SETTLEMENT CONFERENCES AS TO COVIDIEN AND RELATED CASES

- 1. Plaintiffs' counsel in the actions identified on Exhibit A attached hereto whose cases have not been resolved (i.e. dismissed with or without prejudice and are not subject to an agreement in principle to resolve) are directed to meet and confer with Joseph G. Petrosinelli, Esq. of Williams & Connolly, 725 Twelfth Street, N.W., Washington, D.C. 20005, telephone #202-434-5547, settlement counsel for Covidien, Inc. and related parties, on or before June 6, 2018, and to engage in good faith settlement discussions.
- 2. Mr. Petrosinelli is to provide a written report to the court via e-mail no later than June 11, 2018, as to which of the cases set forth in Exhibit A have not been resolved or dismissed.
- 3. As to those cases that have not been resolved or dismissed by June 11, 2018, the court will conduct settlement conferences in Hackensack, New Jersey, at the Bergen County Courthouse, 10 Main Street, Hackensack, NJ, Room 401, beginning at 9:00 a.m. on June 20, 2018, and day to day thereafter.
- 4. The court will enter an order on June 13, 2018, identifying the cases as to which a settlement conference will be conducted.
- 5. Individual plaintiffs whose cases are scheduled for settlement conferences shall appear in person for the settlement conference with their counsel.
- 6. Any plaintiff who fails to comply with this order may be subject to sanctions in accordance with the Rules Governing Courts of the State of New Jersey, including dismissal with prejudice.

- 7. Cases not settled during the settlement conference will be dealt with by further order.
- 8. The Clerk of the Superior Court is directed to file a copy of this order and to publish it in the court's multicounty litigation website. Plaintiffs' liaison counsel is directed to forward a copy of the order to counsel for each of plaintiff's counsel identified on Exhibit A attached hereto within seven (7) days of the date hereof.
