THIS MATTER having been tried before the Honorable James J. DeLuca, J.S.C. and a jury; and the jury having rendered its verdict on April 12, 2018 in favor of Plaintiffs, Mary McGinnis and Thomas Walsh McGinnis, and against C.R. Bard, Inc. on Plaintiffs' claims for inadequate design and failure to warn/instruct with respect to the Avaulta Solo Anterior Support System and the Align TO Transobturdator Urethral Support System; and the jury having rendered its verdict on April 13, 2018 in favor of Plaintiffs and against C.R. Bard, Inc. on Plaintiffs' claim for punitive damages; and for good cause shown;

**ORDERED** as follows:



- 1. Judgment in the amount of \$26,868,967.28 (\$23,026,938.38 plus prejudgment interest in the amount of \$3,842,028.90) is hereby entered in favor of Plaintiff, Mary McGinnis, against Defendant, C.R. Bard, Inc., for Mary McGinnis' past, present and future pain, suffering, disability, impairment and loss of enjoyment of life, and stipulated medical expenses (26,938.38).
- 2. Judgment in the amount of \$11,668,493.15 (\$10,000,000.00 plus prejudgment interest in the amount of \$1,668,493.15) is hereby entered in favor of Plaintiff, Thomas Walsh McGinnis, against Defendant, C.R. Bard, Inc. to compensate Thomas Walsh McGinnis for the loss of the past, present and future value of his loss of consortium.
- 3. Judgment in the amount of \$35,000,000.00 is hereby entered in favor of Plaintiffs against Defendant, C.R. Bard, Inc. for punitive damages.
- 4. The compensatory verdict calculations are calculated with pre-judgment interest through April 12, 2018. Post-judgment interest shall accrue on the compensatory damage awards from April 12, 2018 forward. Post-judgment interest on the punitive damages award shall accrue from April 13, 2018.
- 5. Taxed costs to be entered by the Clerk are hereby awarded to Plaintiffs as per the New Jersey Court Rules.
- 6. A copy of this Order of Judgment shall be served by Plaintiffs' counsel on Defendant's counsel within seven (7) days of the date of the order.
