- 4. Jane Bartley shall have all pleadings, briefs, and other papers filed with the court signed by an attorney of record authorized to practice in New Jersey who shall be held responsible for her, the conduct of the litigation, and of the admitted attorneys herein.
 - 5. Jane Bartley cannot be designated as trial counsel.
- 6. No delay in discovery, motions, trial, or any other proceeding shall occur or be requested by reason of the inability of Jane Bartley to be in attendance.
- 7. Jane Bartley or Stradley Ronon Stevens & Young, LLP, on her behalf, shall pay the fee required by \underline{R} . 1:20-1(b) and \underline{R} . 1:28-2 within 10 days upon receipt of this Order, and shall submit an affidavit of compliance.
- 8. *Pro hac vice* admission will automatically terminate for failure to make the initial and any annual payment required by <u>R.</u> 1:20-1(b) and <u>R.</u> 1:28-2.
- 9. Non-compliance with any of these requirements shall constitute grounds of revocation of Jane Bartley *pro hac vice* admission.
