All prior orders remain in full force and effect
except as modified by this Order.

THIS MATTER having come before the Court via Plaintiffs' and Defendants' Liaison
Counsel; for good cause shown and for the reasons set forth on the record;

IT IS on this 11th day of December, 2025, **ORDERED** as follows:

I. ACTIVATION OF CASES

A. The cases on the attached Exhibit A to this Order are immediately activated for
discovery.¹

1. Any counsel who believes that there is a basis to exempt a case from
discovery activation shall notify both liaison counsel
(aslater@mazieslater.com and kcrawford@riker.com) by December 15,
2025. The Court will make a determination as to whether the case can be
exempt from discovery.

¹ Filed cases that are considered resolved as part of an inventory settlement and for which Defendants await a release
are not included on Exhibit A. If Defendants are notified that a plaintiff is rejecting settlement, Defendants will notify
the Court within 7 days of Defendants' receipt of notification of settlement rejection and will copy that plaintiff's
counsel. Upon notification to the Court, the case will be considered activated and the plaintiff must comply with I.B.1
within 60 days.

2. Any counsel who believes that case(s) in their inventory in the MSA Exhibit B category should be activated for discovery, but is not included on the attached Exhibit A may contact defense liaison counsel (kcrawford@riker.com) to discuss activation.

B. PFS AND MEDICAL AUTHORIZATIONS

1. In all of the cases identified on Exhibit A, plaintiff shall serve by January 9, 2026 (in accordance with the Ethicon PFS Service Protocols²):
 - a. Updated certified PFSs utilizing the forms appended to revised PFS .
 - b. Updated medical authorizations in the forms attached hereto as Addenda B (Marker or LMI as per protocol).
 - c. Product identification stickers for all products/ devices implanted to treat either SUI or prolapse, regardless of whether Plaintiff is making a claim in this civil action related to that product/ device.
 - d. Implant operative report(s).
 - e. Operative report(s) for any mesh revision surgery that occurred as of the date of this Order.
2. Plaintiffs who fail to timely comply with this section of the Order may have their complaint dismissed without prejudice on motion filed by Defendants.

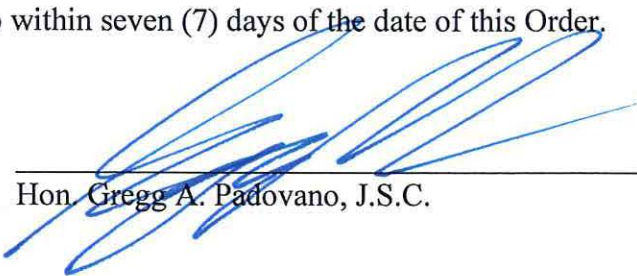
and the current PFS with the current records release authorizations can be located at:

No depositions shall be scheduled in the impacted cases until there has been full compliance with this Order and sufficient medical records have been collected via authorizations provided.

IT IS FURTHER ORDERED that a copy of this Order shall be served upon all counsel for the parties identified in Exhibit A hereto within seven (7) days of the date of this Order.
