Week of May 8: Plaintiffs have requested that Dr. Bernard Jacquetin be scheduled for deposition on May 8 and that Dr. Michel Cosson be scheduled for deposition on May 10.⁴

2. Plaintiffs have requested that Gary Pruden be scheduled for deposition on April 13, 2012 and that Sherilynn McCoy be scheduled for deposition on April 16, 2012. Defendants have objected to the production of these witnesses and will file a motion for a protective order with the Court by February 23, 2012.

3. By February 17, 2012, Defendants shall fully respond to items 1-3 of the January 3, 2012 letter from Plaintiffs' counsel.

4. Defendants shall respond to items 4 through 7 of the January 3, 2012 letter from Plaintiffs' counsel for the Prolift and Prolift +M products, and identify the author of each document identified, as follows: (1) for documents from 2009-Present, by February 15, 2012; (2) for documents from 2005-2009, by February 20, 2012, and (3) for documents up to 2005, by March 2, 2012.

a. Upon receipt of the materials identified in paragraph 3 and 4 above, Plaintiffs shall attempt to prioritize such materials for which they are seeking supporting documentation, including but not limited to "data on file," and unpublished presentations. This provision does not supersede plaintiffs' request for eventual

production of the supporting documentation for all such materials for all Products in this litigation.

5. For all documents previously produced with redactions for nonresponsiveness, Defendants shall remove the non-responsive redactions and re-produce the documents by February 22, 2012, with the exception of documents that shall be the subject of Defendants' motion for a protective order, to be filed by February 23, 2012.

6. By March 2, 2012, Defendants shall serve a written response to the remaining items listed in the January 3, 2012 letter from Plaintiffs' counsel, indentifying the precise status of each request, and each area of dispute requiring resolution. Any disputes not resolved between the parties will be addressed at the next Case Management Conference.

7. The production of databases and raw data and documents from clinical studies shall be made as expeditiously as possible, on a rolling basis, to be completed by March 15, 2012.

8. Social Media required to be produced as per the Stipulation entered on January 31, 2012, shall be provided within ten days for the 14 Core Discovery Cases, and within 30 days for all cases for which PFS responses already have been served, and with PFS responses going forward.
