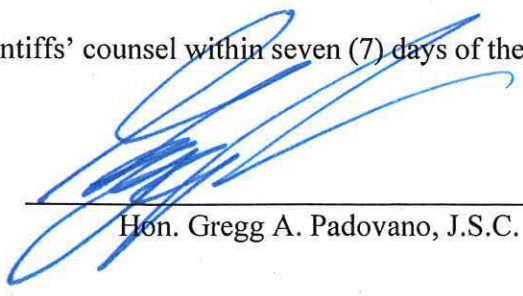
**ORDER OF
