**CONSENT ORDER OF DISMISSAL WITHOUT PREJUDICE**

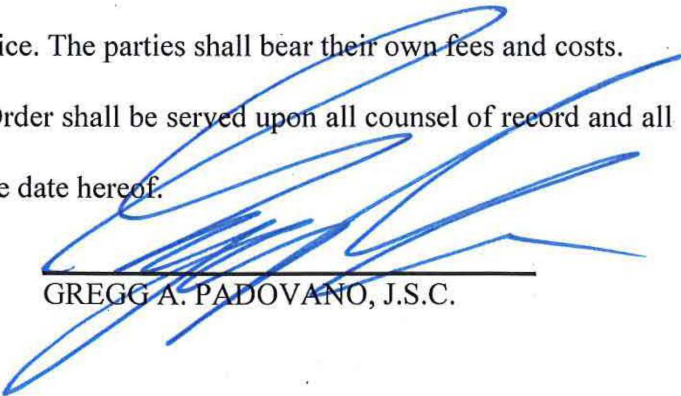
