RIDER

Before this court is the motion of Plaintiffs Sayris J. Gonzalez and Kimberley Sue Hildebrand seeking a protective order regarding deposition subpoenas pertaining to Barry Hildebrand (husband of Kimberley Hildebrand), Ashley Hildebrand and Shonda Griffin (daughters of Kimberley Hildebrand, and Candy Gonzalez (sister of Sayris Gonzalez) by defendants, Ethicon, Inc. and Johnson and Johnson's (hereinafter "Ethicon"). Ethicon opposes this motion arguing that these individuals have ben identified as individuals who possess information relevant to Plaintiffs' injuries and current medical conditions.

With regard to Barry Hildebrand, the husband of Kimberley Hildebrand, he has already been deposed and this court will not allow his redeposition.

Argument was made that Ethicon does not want to be surprised by testimony at the time of trial by the other three fact witnesses. However, it has been represented by Plaintiffs' counsel that other than Barry Hildebrand, these individuals will not be called to testify at the time of trial. With this information, this court does not recognize a legitimate purpose to these depositions. In addition, these names were disclosed years ago and Ethicon waited until now to seek their deposition, when the parties are dealing with expert depositions and pretrial issues. This court is aware as to the intense activity presently in place in preparation for trial, including exchanging deposition designations. Preparing and attending depositions for these three individuals would impose undue burden on Plaintiffs this close to trial, especially in light of the fact that it is known that these three individuals will not be called to testify, and Ethicon thereby suffers no prejudice.
