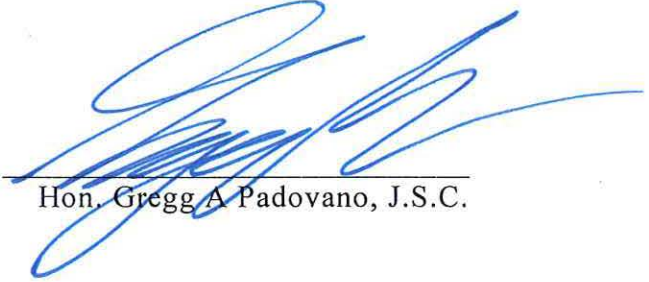
**ORDER WITHDRAWING *NUNC PRO TUNC*
