- 2. Discovery has been proceeding (both written and depositions); the parties shall continue to cooperate in the production of discovery.

## CASE MANAGEMENT:

- The Motion of Weitz & Luxenberg to be Relieved as Counsel for Kenneth Moutenot was GRANTED. A Consent Order has been entered.
- 2. A Discovery Order has been entered and is attached hereto.

## **GENERAL:**

- The next Case Management Conference is scheduled for October
   28, 2013 at 1:30pm. . Counsel shall submit a proposed agenda
   seven (7) days prior to this Case Management Conference.
- 2. By consent of all parties, the court may contact or be contacted on an *ex parte* basis regarding settlement issues *only*.
- 3. The Court directs all counsel to R.1:4-8 and expects all counsel to abide by the parameters set forth therein.
- 4. All Court proceedings will start at the designated scheduled time.

  Counsel is expected to arrive promptly for these proceedings.
- Counsel shall copy their co-counsel and all adversaries on all emails and other electronic correspondence submitted to the Court
