## CASE MANAGEMENT ORDER NO. 32

THIS MATTER having been brought before the Court at a case management conference on August 8, 2018, and counsel for plaintiffs and counsel for defendants having been present, and for good cause shown,

IT IS on this 24 day of August, 2018, ORDERED THAT:

- Minor plaintiffs Devon Mowell (Hill) (L-10263-14), Blake W. Spoon (L-10056-14), and Caden Barrett (L-10714-14), and their appointed guardians or other representatives, and their counsel shall appear in person or by video for a *Friendly* hearing to approve settlement on or before September 25, 2018.
- 2. Minor plaintiff Chad Shulka (L-10635-14), and his mother (if she remains his appointed guardian or other representative), and his counsel shall appear in person or by video for a *Friendly* hearing to approve settlement on or before October 8, 2018. If the plaintiff, or his appointed guardian or other representative, or his counsel fail to appear for a *Friendly* hearing by that date, defendants shall be permitted to file a motion converting the basis for dismissal as to claims asserted against them to a with prejudice dismissal for failure to respond to settlement offers and to comply with this Order.

3. Defendants in the Charles Shumway (L-1-176-14) action are permitted to file a motion converting the basis of the dismissal of claims against them in that action to a with prejudice dismissal for failure to respond to settlement orders and failure to comply with Case Management Order No. 30, which shall have a return date of September 25, 2018 at 11 a.m.

- 5. The remaining Generic Defendants and the Plaintiffs represented by Theodore Oshman, Esq., Ruth Jennings (L-10041-14), Michelle Schwartz (L-10457-14), Melanie Villa (L-10053-14), Gail Young (L-10421-14)), will use their best efforts to complete the depositions of the prescribing physicians of these "opt-out" plaintiffs by September 30, 2018.
- 6. The next case management conference is scheduled for September 25, 2018 at 11 a.m. Prior to that conference, Plaintiffs Liaison Counsel and counsel for defendants shall meet and confer regarding whether it is appropriate to dissolve the consolidated proceeding.
