ALAVEN AND SCHWARZ ONLY**


On January 25, 2011, Plaintiff filed a Short Form Complaint in the Superior Court of New Jersey in Atlantic County, New Jersey. The Short Form Complaint did not name Alaven Pharmaceutical LLC ("Alaven") or Schwarz Pharma, Inc. n/k/a UCB, Inc. ("Schwarz") as defendants. On June 7, 2011, Plaintiff filed an amended complaint in the Superior Court of New Jersey in Atlantic County, New Jersey. The amended complaint did not name Alaven or Schwarz as defendants.

As a result of a clerical error, Alaven and Schwarz are listed as defendants on the docket in this matter.

Plaintiff agrees that she never filed a complaint, amended or otherwise, against or naming Alaven and Schwarz and that Alaven and Schwarz should not be listed as defendants on the docket in this matter.

Therefore, and on that basis, it is hereby stipulated and agreed that the claims of **PLAINTIFF, VIVIAN POWERS**, are now hereby dismissed, without costs against either party, with prejudice as to **DEFENDANTS, ALAVEN PHARMACEUTICAL LLC AND SCHWARZ PHARMA, INC. N/K/A UCB, INC., ONLY.**


