This matter having been opened to the Court by Moishe Maimon, attorney for Plaintiff

D.R. 1, and the Court having considered the moving papers, and for good cause shown,

IT IS on this 18th day of August, 2025, ORDERED as follows:

1. That Plaintiff, D.R. 1's individual complaint filed on August 8, 2025, shall be deemed to relate back for all purposes, including any statute of limitations or repose defenses, to the original multi-plaintiff complaint filed on April 22, 2024, in SOM-L-000498-24.

2. This ruling is made in light of the Supreme Court's Order of May 28, 2025; designating this a multicounty litigation for centralized management purposes; and the Court's July 3, 2025 Order, ordering "If a Complaint has been filed with multiple unrelated plaintiffs, new individual Complaints must be filed within thirty (30) days, and upon request the court will sign an order preserving the original date of filing."
3. This ruling is also pursuant to R. 4:9-3 and in light of the equitable considerations relevant to claims arising under the Child Sexual Abuse Act (N.J.S.A. 2A:61B-1 et seq.) and L.2019, c.120, which expanded the statute of limitations for such claims.
4. A copy of this Order shall be served on all parties within five (5) days.
