issued pursuant to the terms of this Order.

3. Following issuance of the notices to plaintiffs and written update to the Court and Lead

Counsel required in #1 above, current counsel for the named plaintiffs shall be

permitted to withdraw as counsel.

4. Each of the named plaintiffs (or the new legal counsel or legal representatives of any

deceased party/parties) identified in the matters set forth above shall appear (Via

Telephonic Conference) and show cause on Monday, March 27, 2023 at 11AM

(Eastern Time) why his/her unrevised plaintiff case should not be removed from the

trial calendar and dismissed from the MCL docket with prejudice;
