**THIS MATTER** having been assigned to the Honorable Rachelle L. Harz, J.S.C., pursuant to the Supreme Court's Order of April 6, 2021, designating this matter for Multicounty Litigation ("MCL") status, and the Court having received a proposed agenda from counsel for the parties, and having conducted a Case Management Conference on August 11, 2021 (via WebEx), and for the reasons set forth on the record and good cause shown,

**IT IS** on this 19<sup>th</sup> day of August, 2021, **ORDERED:**

1. **Vacate Order**

This Court's Orders dated August 18, 2021 and August 12, 2021 are hereby vacated.

2. **Response to Master Complaint**

Defendant's response to the Master Complaint shall be due on September 15, 2021.

3. **Plaintiff Fact Sheets/Defendant Fact Sheets**

On September 3, 2021, Defendant shall provide Plaintiff a proposed Plaintiff Fact Sheet and Plaintiffs shall provide Defendant with a proposed Defendant Fact Sheet. The parties shall then meet and confer to narrow any issues in dispute. On September 20, 2021, Defendant shall submit the proposed Plaintiff Fact Sheet and Plaintiffs shall submit the proposed Defendant Fact Sheet to the Court. Any objections thereto from the opposing party shall also be submitted at that

time. Any unresolved disputes will be addressed by the Court at the next Case Management Conference.

4. **Discovery**

To address the parties' present disputes regarding the identity of individuals to be included in productions of custodial documents and search terms, this Court will be coordinating with the MDL Court in the United States District Court Middle District of Florida. Due to a conflict, the previously designated Special Discovery Master, Honorable Joel Schneider, United States Magistrate Judge (Ret.), is unable to serve as Special Discovery Master in this matter.

5. **Case Management Conferences**

The Court will conduct the next Case Management Conference on **September 29, 2021, at 10:30 AM Eastern time** via WebEx conference.

Counsel shall submit an agenda for the Case Management Conference seven (7) days prior to the Case Management Conference, which shall be submitted by email to antonious.sadek@njcourts.gov. The Court will conduct conferences, anticipated to be held every 45 to 60 days, and in addition the parties may request status, scheduling, and case management conferences to discuss the progress regarding relevant issues. Reasonable notice of all such conferences will be provided to all counsel of record.

Counsel shall keep the Court apprised of any relevant developments regarding this matter.
