CASE MANAGEMENT ORDER NO. 4

IT IS on this _____ day of July, 2019, ORDERED as follows:

- 1. The Parties shall submit a revised case list to the Court by July 16, 2019.
- 2. The Parties shall meet and confer and submit to the Court a proposed Order regarding Plaintiffs who have not produced any documentary evidence of proof of use and/or manufacturer identification in accordance with the January 23, 2019 Order by April 26, 2019.
- 3. The Parties shall meet and confer as to a supplemental product identification order.
 If a resolution cannot be reached, the Parties shall submit competing orders with corresponding submissions setting forth their positions to the Court by May 16, 2019.
- 4. The Parties shall meet and confer regarding a revised Plaintiff Fact Sheet and proposed Implementation Order for the Plaintiff Fact Sheet and Defendant Fact Sheet. If a resolution cannot be reached, the Parties shall submit competing orders

- with corresponding submissions setting forth their positions to the Court by May 16, 2019.
- 5. Counsel for Defendants Actavis Pharma, Inc., Actavis LLC, and Sagent Pharmaceuticals, Inc., and Plaintiffs' counsel shall meet and confer to discuss the scope of discovery as to those defendants by May 2, 2019.
- 6. The next Case Management Conference is scheduled for July 23, 2019 at 10:00

 Courthouse, 56 Patterson Street, New Brunswick, New Jersey. The Parties shall submit a joint agenda to the Court listing the issues for the case management conference, via e-mail, by 12:00 PM on July 16, 2019. Liaison Counsel for the parties shall circulate a dial-in to all counsel of record and the Court prior to the conference. Plaintiffs' Liaison Counsel shall sent a proposed agenda to Defendants' Liaison Counsel on or before May 28, 2019.
- 7. The Court will seek to obtain and review the MDL Science Day video from Judge Milazzo. On or before \(\frac{7\lambda}{2} \), 2019, the Court will advise Liaison Counsel whether Science Day in New Jersey will go forward, and if so, is confirmed for June 11, 2019 along with the Court's requested format for Science Day.
