Fraxedas, Esq. shall have all pleadings, briefs and other papers filed with the Court in this action signed by an attorney of record authorized to practice in this State, specifically the New York, New York office of Robins Kaplan LLP, who shall be responsible for them and for the conduct of the cause and of the admitted attorney herein;
- 5. Jason R. Fraxedas, Esq. must, within 10 days, pay the fees required by <u>Rule</u> 1:20-1(b) and <u>Rule</u> 1:28-2 and submit affidavits of compliance;
