CASE MANAGEMENT ORDER NO. 11 (EXTENSION OF TIME FOR DISMISSAL OF BAYER GERMAN DEFENDANTS)

[All prior Orders remain in full force and effect except as modified by this Order]

The Plaintiffs representing that they may name certain foreign entities as defendants to this matter, namely Bayer AG and Bayer Schering Pharma AG (hereinafter collectively referred to as the "Bayer German Defendants"), and that if that happens, said potential defendants will need to be served with the Summons and Complaint pursuant to the Hague Convention on the Service Abroad of Judicial and Extra-Judicial Documents in Civil or Commercial Matters, (20 U.S.T. 361; 658 U.N.T.S. 163) ("the Hague Convention"), and understanding that said defendants presently refuse to accept service of process in any other fashion, and the parties consenting to the form, substance and entry of this Order, and this Court acknowledges that the service of process pursuant to the Hague Convention is a time-consuming procedure that constitutes exceptional circumstances to extend four-month time period specified in Rule 1:13-7(a) at which point a Court Notice would be automatically generated that a defendant would be dismissed without prejudice from the action in 60 days if none of

the proceedings specified in Rule 1:13-7(b) take place, and this Court being desirous of avoiding numerous individual Motions being filed to expand that aforementioned time period and/or numerous individual Motions to reinstate the action against the Bayer German Defendants,

IT IS ON THIS 12 DAY OF August, 2010

ORDERED,

- 1. The four-month time period specified in Rule 1:13-7(a), at which point a Court Notice would be automatically generated that a defendant would be dismissed without prejudice from the action in 60 days if none of the proceedings specified in Rule 1:13-7(b) take place, is hereby extended for **CNE YEAR** from the date of entry of this Case Management Order No. 11, as to the Bayer German Defendants;
- 2. Counsel for any plaintiff that receives a Court Notice pursuant to Rule

 1:13-7 that any of the Bayer German Defendants will be dismissed without prejudice for lack of prosecution may present this Case Management Order No. 11 to the Clerk of the Superior Court to extend the date specified in Court Notice for the dismissal without prejudice of the Bayer German Defendants for ONE EAR from the date of entry of this Order.
