CASE MANAGEMENT ORDER #20 SEPTEMBER 23, 2021 CASE MANAGEMENT CONFERENCE

THIS MATTER, having come before the Court at a case management conference on September 23, 2021 and counsel for plaintiffs and counsel for defendants having been present, and for good cause having been shown;

IT IS on this 4th day of October, **ORDERED** as follows:

### 1. CONSENT ORDERS FOR MOTIONS TO DISMISS WITHOUT PREJUDICE

Liaison counsel shall meet and confer regarding a procedure that would provide a consent order to dismiss a case without prejudice if plaintiff has not provided overdue proof of use, a plaintiff fact sheet, or a deficiency response by a specified date or failure to comply with a court order. The attorneys will report back to the Court regarding the meet and confer on a date to be scheduled the first week of October, at the court's convenience.

### 2. MOTIONS TO BE FILED IN THE NEXT THIRTY DAYS

Counsel have permission to file the motions set forth in Exhibit A.

### 3. DOUGLAS AND LONDON APPEARANCES

Douglas and London shall provide a list of cases pending in the MCL for which the general notice of appearance in the main docket, MID-L-4999-18 shall apply to by September 30, 2021.

#### 4. MCKESSON DISMISSAL

Plaintiffs' counsel from the Marc J. Bern & Partners LLP law firm have agreed to dismiss McKesson from all pending cases and not to file any further claims against McKesson in this litigation. The parties have consented to an omnibus dismissal Order, which shall be filed in the general Zostavax docket, MID-L-4999-18, with a list of all individual cases pending that are subject to dismissal. Following entry of the Order, the Court shall upload the dismissal Order into the dockets for each of the individual cases subject to dismissal. McKesson shall not be required to file responsive pleadings in any cases included in MCL 629, and Plaintiffs shall not serve McKesson with new or reinstated cases included in MCL 629. Counsel for McKesson are not required to appear for any further case management conferences.

### 5. NEXT CASE MANAGEMENT CONFERENCE

The next Liaison Counsel Meeting is scheduled for November 3, 2021 at 9:00 A.M. via a video link, which shall be circulated by liaison counsel on a later date. The next Case Management Conference is scheduled for November 8, 2021 at 9:30 A.M., via a video link, which shall be circulated by the Court on a later date.
