- 2. Raquel Flynn, Esq. shall, and hereby do, consent to the appointment of the Clerk of the Supreme Court as their agent upon whom service of process may be made for all actions against Raquel Flynn, Esq. that may arise out of their participation in the matter.
- 3. Raquel Flynn, Esq. shall immediately notify the Court of any matter affecting their standing with the Bar of any other jurisdiction.
- 4. Raquel Flynn, Esq. shall have all pleadings, briefs, and other papers filed with the Court signed by an attorney of record authorized to practice in New Jersey, who shall be held responsible for them, the conduct of the litigation, and the attorney admitted herein.

- 9. Non-compliance with any of the terms of this order shall constitute grounds for removal.
