PROPOSED AMENDMENTS TO RULE 1:38-3(f) TO EXCLUDE FROM PUBLIC ACCESS NEW CONFIDENTIAL FORMS REQUIRED FOR CIVIL ADULT NAME CHANGE APPLICATIONS – PUBLICATION FOR COMMENT

An application for an adult name change in the Civil Division requires the submission of confidential personal identifiers, including the applicant's full Social Security number. Name change applications were until recently filed on paper. As of October 22, 2018, however, these applications are required to be filed electronically in eCourts, the Judiciary's electronic filing and recordkeeping system.

In preparation for the transition to electronic filing of adult name change applications in the Civil Division, the Judiciary revised its forms to remove the applicant's Social Security number from the Verified Complaint form and instead to require its submission in a new Certification of Confidential Information for Name Change form. The revised forms also now exclude the Social Security number from the Final Judgment form and instead require it in a new Final Judgment Addendum form. In creating the new Certification and new Addendum forms, the intention was for these documents to be excluded from public access and that they be treated as confidential in eCourts.

Since electronic filing of name change applications started in October 2018, the Judiciary as required by <u>R.</u> 1:38-7(e) individually has excluded from public access the Social Security numbers of name change applicants. Along those same lines, the Judiciary now proposes to protect from public access the Social Security numbers in the two new forms. Attached is the proposed amendment to <u>R.</u> 1:38-3(f) to add to the categories of documents excluded from public access the Certification of Confidential Information for Name Change and Final Judgment Addendum. This amendment will ensure that these documents are treated as confidential in eCourts.
