

NOTICE TO THE BAR

CIVIL CASE INFORMATION STATEMENT (CIVIL CIS) – REVISIONS TO SIDE 2 REGARDING TRACK IV CASE TYPES

The Civil Case Information Statement (“Civil CIS”) is included in the Rules of Court as Appendix XII-B1. The Supreme Court previously delegated to the Administrative Director the authority to approve revisions to Side 2 of the Civil CIS. This Notice is to advise the bar of two revisions to the list of Track IV case types shown on Side 2, as follows:

- the addition of case type 287 for the Yaz/Yasmin/Ocella litigation, pursuant to the Supreme Court’s February 9, 2010 Order designating the litigation as a mass tort; and
- the addition of case type 288 for the Prudential Tort litigation, pursuant to the Supreme Court’s February 9, 2010 Order centralizing the management of the litigation but not designating it as a mass tort.

These revisions are effective April 1, 2010. The complete Civil CIS as thus revised is attached (both sides). No changes are being made at this time to Side 1 of the CIS.
