

# NOTICE TO THE BAR

## **CIVIL CASE INFORMATION STATEMENT (CIVIL CIS) – REVISIONS TO SIDE 2 REGARDING TRACK IV CASE TYPES**

The Civil Case Information Statement (“Civil CIS”) is included in the Rules of Court as Appendix XII-B1. The Supreme Court previously delegated to the Administrative Director the authority to approve revisions to Side 2 of the Civil CIS. This Notice is to advise the bar of the approval of several such revisions to Side 2. The complete Civil CIS as revised is attached. No changes have been made to Side 1 of the CIS. The approved revisions, which are effective May 7, 2012, are as follows:

- the addition of case type 623 for the Propecia litigation, pursuant to the Supreme Court’s March 7, 2012 Order centralizing the management of the litigation but not designating it as a mass tort;
- the removal of case type 280 for the Zelnorm litigation, pursuant to the Supreme Court’s November 9, 2011 Order terminating centralized management of the litigation;
- the removal of case type 248 for the Ciba Geigy litigation, pursuant to the Supreme Court’s September 13, 2011 Order terminating the mass tort designation and centralized management of the litigation;
- the removal of case type 294 for the Plavix litigation, pursuant to the Supreme Court’s January 24, 2012 Order terminating centralized management of the litigation;


