

## NOTICE TO THE BAR

### PROPOSED SCHEDULE OF STATE COURT FEE INCREASES PURSUANT TO L. 2014, c. 31 – COMMENTS REQUESTED

The Supreme Court requests comment on the attached proposed schedule of state court fee increases pursuant to L. 2014, c. 31 (S. 946). That legislation, signed into law on August 11, 2014, authorizes the Court to “adopt Rules of Court to revise or supplement filing fees and other statutory fees payable to the court for the sole purpose of funding: (1) the development, maintenance and administration of a Statewide Pretrial Services Program; (2) the development, maintenance and administration of a Statewide digital e-court information system; and (3) the provision to the poor of legal assistance in civil matters by Legal Services of New Jersey and its affiliate.” L. 2014, c. 31, §12a. That authorization will expire on March 1, 2015. L. 2014, c. 31, §19.

The information in the proposed schedule of state court fee increases is listed by court, with the first section applicable to all state courts and the sections in sequence after that specifically applicable to the Supreme Court, the Appellate Division, the Civil Division, the Special Civil Part, General Equity, the Family, Criminal, and Probation Divisions, the Superior Court Clerk’s Office, and the Tax Court. The information is displayed in columns as follows: “Fee Type” (whether the proposed action is the increase of an existing fee or the adoption of a fee where there is at present no fee); “Fee Subject” (a description of the fee); “Current Fee”; “Proposed Fee”; and “Statute/Court Rule” (setting out the underlying statutory or rule basis for the particular fee).

The comment period will run through Wednesday, October 15, 2014, with the Court thereafter to act on the proposed fee schedule. The projected effective date of the fee increases and new fees that will be adopted through this process is Monday, November 17, 2014. The approved fee schedule will be included in the Rules of Court as an Appendix, consistent with the legislation.

In addition to written comments, the Court will hold a hearing on the proposed revised fee schedule on Tuesday, October 21, 2014, at 3 p.m. in the Supreme Court courtroom in the Hughes Justice Complex in Trenton. Anyone who wishes to speak at the October 21 hearing must notify the Administrative Director of the Courts in writing prior to that date by regular mail at the address set forth above or by email to the following address: Comments.Mailbox@judiciary.state.nj.us. The request must specify whether the speaker will be representing an organization. Please note that the time limit on each speaker's presentation will be five minutes.
