CIVIL CASE INFORMATION STATEMENT (CIVIL CIS) –
REVISIONS TO SIDE 2

The Civil Case Information Statement ("Civil CIS") is included in the Rules of Court as Appendix XII-B1. The Supreme Court has previously delegated to the Administrative Director the authority to approve revisions to Side 2 of the Civil CIS. This Notice is to advise the bar of the approval of revisions to Side 2 of the Civil CIS. The complete Civil CIS as revised is attached. The approved revisions to Side 2, which are effective May 4, 2015, are as follows:

- The **removal of case type 266** for litigation involving Hormone Replacement Therapy (HRT) pursuant to the Supreme Court's March 24, 2015 Order; and
- The **removal of case type 284** for the litigation involving the NuvaRing® contraceptive device, pursuant to the Supreme Court's March 24, 2015 Order.
