CIVIL CASE INFORMATION STATEMENT (CIVIL CIS) – REVISION TO SIDE 2

The Civil Case Information statement (“Civil CIS”) is included in the Rules of Court as Appendix XII-B1. The Supreme Court has previously delegated to the Administrative Director the authority to approve revisions to Side 2 of the Civil CIS. The complete Civil CIS as revised is attached. The approved revisions to Side 2, which are effective December 7, 2015 are as follows:

- The addition of case type 299 for litigation involving Olmesartan Medoxomil Medications pursuant to the Supreme Court’s July 14, 2015 Order.
- The addition of case type 300 for litigation involving talc-based body powder products used for feminine hygiene purposes pursuant to the Supreme Court’s October 20, 2015 Order.
