

Re: Application Pursuant to <u>Rule</u> 4:38A ("Centralized Management of Multicounty Litigation") to Designate the Taxotere (Docetaxel) Cases as a Multicounty Litigation for Centralized Management.

Dear Judge Grant:

Plaintiffs respectfully submit this letter application requesting that the Taxotere cases currently filed in several New Jersey counties be designated as a Multi-County Litigation ("MCL") for centralized management. In addition, Plaintiffs request that the MCL be assigned to Honorable James F. Hyland, J.S.C., in Middlesex County, where the majority of the cases are currently pending.¹

BACKGROUND

This application addresses approximately 353 currently pending cases identified in the Schedule of Actions ("Actions"), as well as any similar cases, filed in the Superior Court of New Jersey. Specifically, these Actions involve claims by women who have suffered permanent hair loss (alopecia) and other disfigurement, as a result of using the chemotherapy drug known as Taxotere (docetaxel) and as part of their treatment for breast cancer. Though the Defendants were aware of the risk of **permanent** hair loss, they failed to warn of this and related risks for many years. Plaintiffs seek damages for personal injuries they suffered as a result of the wrongful conduct of Defendants in designing, manufacturing, distributing, labeling, advertising, marketing, promoting, and selling Taxotere for the treatment of breast cancer.

The complaints include product liability and fraud claims against several defendants, including Sanofi U.S. Services, Inc. and Sanofi-Aventis U.S. LLC, both with a principal places of business in Bridgewater, New Jersey; Sandoz Inc., with a principal place of business in Princeton, New Jersey; and Actavis LLC, with a principal place of business in Parsippany, New Jersey. Many of the plaintiffs are New Jersey residents, who reside throughout the state of New Jersey. In total, there are approximately 333 cases pending in Middlesex County, as well as other cases pending in Bergen County, Camden County, Union County, Essex County, and Hudson County.

Of note, there is a pending federal multidistrict litigation (MDL). The Judicial Panel of Multidistrict Litigation (JPML) assigned the federal Taxotere cases to the Honorable Lance M. Africk,² in the Eastern District of Louisiana. (*See* October 5, 2016 JPML Transfer Order entered in Case MDL No. 2740 In Re:

Taxotere (Docetaxel) Products Liability Litigation, attached hereto as **Exhibit B**.) There are approximately 8,037 cases pending in the MDL litigation.

ARGUMENT

The parties submit that this litigation meets the criteria required under Directive #8-12 for Centralized Case Management and respectfully request that these cases be consolidated for case management in the Middlesex County Superior Court before Judge James F. Hyland, J.S.C., where the majority of the cases are currently pending.

I. These Cases Satisfy The Criteria For MCL Case Management.

A. The Taxotere (docetaxel) litigation involves a large number of parties that are geographically dispersed around the State of New Jersey and the country.

As with other Multicounty Litigations centralized by this Court, the Taxotere (docetaxel) litigation involves a large number of parties that are geographically dispersed. The current actions filed in New Jersey involve plaintiffs from a number of different states, including New Jersey, Pennsylvania, Maryland, Ohio, and Connecticut. In addition, the current New Jersey actions are filed in several vicinages, including Essex County, Camden County, Union County, Middlesex County, and Hudson County.³ The parties submit that this geographical diversity makes Centralized Management necessary for the efficient handling of this litigation.

B. The Taxotere (docetaxel) litigation involves many claims with common, recurrent issues of law and fact that are associated with a single prescription ingredient alleged to cause similar injuries among the plaintiffs.

The Taxotere (docetaxel) cases involve numerous claims with common, recurrent, and complex issues of law and fact. All of these cases involve the chemotherapy drug known as Taxotere (docetaxel). All of the plaintiffs claim that defendants knew, or should have known, that Taxotere (docatexal) causes and contributes to permanent disfigurement and hair loss, and that defendants failed to adequately warn of those risks. Further, all of the actions proposed for designation allege substantially similar violations of law and are based upon the same or substantially similar underlying claims surrounding the safety profile of Taxotere (docetaxel).

Centralized management will conserve judicial resources and provide all parties with the benefits of coordinated discovery. At present, the majority of cases in this litigation are pending in Middlesex County, and awaiting docket numbers and pretrial judge assignments. To date, this litigation is at the pleadings stage. Centralization is expected to provide a fair and more convenient, cost effective process for all parties, witnesses, counsel and the Court.

C. Centralization will help facilitate coordination with the MDL litigation.

As previously discussed above, there are a number of Taxotere (docetaxel) cases pending in federal court for several years, with the first MDL trial scheduled to start in September 2018. Centralization of these cases is expected to promote effective coordination with the MDL, and thus serves the goal of efficient and inexpensive administration of cases, while maintaining the independence of the New Jersey litigation.

D. Centralized management is fair and convenient to the parties, witnesses, and counsel.

Given the large number of parties, witnesses, and counsel, the cases would benefit from centralized management. Centralized management will also minimize duplicative practice and inconsistent discovery rulings. Additionally, the majority of the cases are currently pending in Middlesex County but are not yet assigned to pretrial judges or given docket numbers. Centralization will provide Judge Hyland with the ability to manage these cases from the beginning in an efficient and effective manner.

II. All Known Plaintiffs' Counsel Agree that These Cases Should be Assigned to Judge Hyland for Centralized Management, and that Middlesex County is the Most Appropriate Venue for These Cases.

Issues of fairness, geographical location of the parties and attorneys, and the existing civil and mass tort caseload in the vicinage are considered when determining the vicinage to assign a particular mass tort for centralized management. *See Mass Torts-Guidelines and Criteria for Designation*, at 2 (Oct. 25, 2007).

In light of the number of cases already pending in Middlesex County, it is both logical and efficient for the MCL to be assigned to Judge Hyland in Middlesex County. Bergen County's Assignment Judge, the Hon. Bonnie F. Mizdol, found Middlesex County to be a location convenient to the parties and witnesses in her January 5, 2018 Order transferring the Bergen County cases to Middlesex County. (*See* Ex. C at 1.) In addition, the overwhelming majority of the cases are currently pending in Middlesex County. Accordingly, it is both logical and fair to the litigants for these cases to remain in Middlesex County for centralized management.

III. In the Event this Court Grants an MCL Designation, the MCL Judge Should be Permitted to Return the Cases to the Plaintiffs' Respective Home Counties for Trial.

Should the Supreme Court grant an MCL designation for this litigation, this Court should also protect and take into account the rights of plaintiffs who reside in New Jersey. Pursuant to <u>Rule</u> 4:3-2, a New Jersey plaintiff has several venue

options, including the plaintiff's home county. A plaintiff residing in New Jersey should be permitted to choose to litigate her case in her home county, in accordance with <u>Rule</u> 4:3-2(a). "Indeed, the rule itself expresses a bias in favor of plaintiff's choice." <u>Doyley v. Schroeter</u>, 191 <u>N.J. Super</u>, 120, 125 (Law Div. 1983). The policies behind MCL designation are satisfied by coordinating general discovery and general issues applicable to all plaintiffs. At the conclusion of all pre-trial proceedings in the MCL, the New Jersey plaintiff's case should be returned to the plaintiff's chosen county for trial. A New Jersey plaintiff should be permitted to have her case tried in that New Jersey resident's chosen county, if the plaintiff so chooses.

This Court has previously provided that the MCL judge may return cases to the original or otherwise selected county of venue for disposition. *See* Olmesartan Medoxomil Medications MCL Order, attached hereto as **Exhibit D**, stating "all future such complaints, no matter where they might be venued, shall be filed in Atlantic County and assigned to Judge Johnson," and in the next paragraph indicating that the MCL Judge will, "oversee all management and trial issues for such cases, and may, in his discretion, return such cases to the original county of venue for disposition" Plaintiffs respectfully request that a similar provision be included for purposes of this litigation.

A contrary decision would severely prejudice a New Jersey plaintiff who does not reside in or near the county to which centralized litigation is assigned, potentially requiring the plaintiff to live away from home, at great inconvenience and expense, due to the happenstance that there are multiple other related cases pending. Allowing the MCL judge to transfer the cases for trial to the plaintiffs chosen county will protect the plaintiff's rights, while promoting the primary goal of centralization – efficiency and consistent management and orders through the discovery process. Assignment of the case for trial in the plaintiff's chosen county,

will serve to fairly balance the plaintiff's rights while achieving the goals and benefits of centralization.

CONCLUSION

In light of all the factors and information discussed above, the Plaintiffs respectfully request that pursuant to <u>Rule</u> 4:38A, the Taxotere (docetaxel) cases be designated as Multicounty Litigation for Centralized Management and be assigned to Judge Hyland, for efficient and effective administration.

UNITED STATES JUDICIAL PANEL on MULTIDISTRICT LITIGATION

TRANSFER ORDER

Before the Panel: Plaintiffs in the Eastern District of Louisiana Veronica Smith and District of Colorado Gahan actions, listed on Schedule A, move under 28 U.S.C. § 1407 to centralize pretrial proceedings in this litigation in the Eastern District of Louisiana or, alternatively, the Southern District of Illinois. This litigation consists of thirty-three actions pending in sixteen districts, as listed on Schedule A. The Panel also has been notified of fifty-six related actions pending in twenty-five districts.¹

All parties agree that centralization is warranted, but disagree as to the most appropriate transferee district. Plaintiffs in ten actions and potential tag-along actions have responded to the motion, and they variously argue in support of centralization in the Eastern District of Louisiana, the Southern District of Illinois, the District of Minnesota, the Northern District of Illinois, the Southern District of Mississippi, or the Northern District of California. Responding defendant Sanofi-Aventis U.S. LLC (Sanofi-Aventis) suggests centralization in the District of Colorado or the District of New Jersey or, alternatively, supports centralization in the Eastern District of Louisiana, the District of Minnesota, or the Northern District of Illinois.

On the basis of the papers filed and hearing session held, we find that these actions involve common questions of fact, and that centralization in the Eastern District of Louisiana will serve the convenience of the parties and witnesses and promote the just and efficient conduct of this litigation. All the actions share common factual questions arising out of allegations that Taxotere (docetaxel), a chemotherapy drug, causes permanent hair loss, that defendants were aware of this possible side effect and failed to warn patients, and that defendants marketed Taxotere as more effective than other chemotherapy drugs when other drugs were equally effective without the associated permanent hair loss. Plaintiffs in these actions each allege that they experienced permanent hair loss as a result of using Taxotere. All actions will require discovery regarding the design, testing, manufacturing, marketing, and labeling of Taxotere. Centralization will eliminate duplicative discovery; prevent inconsistent pretrial rulings; and conserve the resources of the parties, their counsel, and the judiciary.

Given the geographic dispersal of the pending actions and the widespread nature of this litigation, no particular district or region emerges as a clear focal point. We are persuaded that the Eastern District of Louisiana is an appropriate transferee forum. Plaintiffs in six actions and potential tag-along actions and responding defendant support centralization in this district, in the first instance or in the alternative, and ten actions and potential tag-along actions already are pending there. The Eastern District of Louisiana is an easily accessible and reasonably central district. Additionally, Judge Lance M. Africk is a seasoned jurist who is willing and able to handle this litigation, but who has not yet had the opportunity to preside over an MDL.

IT IS THEREFORE ORDERED that the actions listed on Schedule A and pending outside the Eastern District of Louisiana are transferred to the Eastern District of Louisiana and, with the consent of that court, assigned to the Honorable Lance M. Africk for coordinated or consolidated pretrial proceedings.

DESIGNATION OF CERTAIN NEW JERSEY STATE-COURT LITIGATION INVOLVING OLMESARTAN MEDOXOMIL MEDICATIONS AS MULTICOUNTY LITIGATION

A previous notice to the Bar requested comments on an application for multicounty litigation designation of all New Jersey state court litigation involving olmesartan medoxomil medications. This Notice is to advise that the Supreme Court, after considering the application and comments received, has determined to designate litigation alleging personal injuries of sprue-like enteropathy and/or lymphocytic colitis, microscopic colitis or collagenous colitis and other symptoms as a result of treatment with olmesartan medoxomil medications as multicounty litigation. The Court has assigned this litigation to Atlantic County for centralized case management by Superior Court Judge Nelson C. Johnson.

On application made pursuant to Rule 4:38A and the Multicounty Litigation Guidelines promulgated by Directive # 08-12 in accordance with that Rule, it is ORDERED that all pending and future New Jersey state court actions alleging personal injuries resulting from treatment with **olmesartan medoxomil medications** is hereby designated as multicounty litigation ("MCL") for centralized case management purposes; and

It is FURTHER ORDERED that any and all such complaints that have been filed in the various counties and that are under or are awaiting case management and/or discovery shall be transferred from the county of venue to Superior Court, Law Division, Atlantic County and assigned to Judge Nelson C. Johnson; and that, pursuant to N.J. Const. (1947), Art.VI, sec.2, par. 3, the provisions of Rule 4:3-2 governing venue in the Superior Court are supplemented and relaxed so that all future such complaints, no matter where they might be venued, shall be filed in Atlantic County and assigned to Judge Johnson; and

It is FURTHER ORDERED that Judge Johnson shall oversee all management and trial issues for such cases and may, in his discretion, return such cases to the original county of venue for disposition; and

If is FURTHER ORDERED that no Mediator or Master may be appointed in this litigation without the express prior approval of the Chief Justice.
