	more, proof beyond a reasonable doubt that defendant was in
	constructive possession of [that contraband]. It is, however, a
	circumstance to be considered with the other evidence in determining whether the State has proven possession of the [contraband] beyond
	a reasonable doubt."

N.J.S.A. 2C:39-5(j)	Unlawful Possession of a Handgun– Prior NERA Conviction (First Degree) (6/11/18) This is a new model charge.
