Dear Judge Grant:

This letter is submitted on behalf of a growing number of Plaintiffs regarding a related lawsuits filed against HealthPlus Surgery Center in Bergen County and Essex County, New Jersey, as well as related cases in the United States District Court in Newark, New Jersey. The purpose of this letter is to request a case classification as Multicounty Litigation, pursuant to New Jersey Court Rule 4:38A.

#### BACKGROUND

Each of the cases listed above involves serious personal injuries that have resulted from lapses in infection control in sterilization/cleaning of instruments at the HealthPlus Surgery Center located at 190 Midland Avenue in Saddle Brook, New Jersey.

Each of the plaintiffs involved received a procedure at the HealthPlus Surgery Center between January 1, 2018 and September 7, 2018. Thereafter, they received a letter via certified mail from the HealthPlus Surgery Center, indicating:

An investigation by the New Jersey Department of Health revealed that during this time period, lapses in infection control in sterilization/cleaning instruments and the injection of medications may have exposed patients to blood born pathogens (diseases in people's blood), such as hepatitis B, hepatitis C, and human immunodeficiency virus (HIV).

### WHY COORDINATION IS APPROPRIATE

Our office is currently retained by approximately 80 plaintiffs who have been injured as a result of HealthPlus Surgery Center's negligence. We are aware that other law firms have additional plaintiffs as well, and we are notifying them of this request for multicounty litigation classification by way of this letter. There are an estimated 3,800 people affected by HealthPlus Surgery Center's negligence in this regard.

The plaintiffs identified to date are geographically dispersed. Our current plaintiffs reside in Bergen County, Essex County, and New York State. Additional plaintiffs may expand the geographical locations beyond these parameters.

We believe centralized management would be fair and convenient to all parties, witnesses, and counsel. The cases will involve the same legal theories, and most likely the same experts. The cases will be subject to the same motions, and would benefit from consolidated Court Orders. Moreover, should the cases be tried separately, they may result in inconsistent Court Orders and rulings, despite having largely the same fact pattern and liability. Indeed, coordinated discovery would facilitate the resolution of the cases.

Additionally, at this time, issues remain as it pertains to insurance, limits on assets, and potential bankruptcy, which would be best addressed as a whole through coordinated proceedings. The resolution of such issues will affect each case. The issue of insurance coverage is currently being litigated in the cases filed in Federal Court.

Class actions lawsuits were filed in the State Superior Court, and thereafter removed to Federal Court. However, to the extent

that the cases stay in Federal Court, the related matters will require coordination with a single New Jersey judge.

### WHY BERGEN COUNTY IS AN APPROPRIATE MASS TORT VENUE

Presently, these cases are filed and pending before a number of different Judges in Bergen County. Issues of fairness, geographical location of the parties and attorneys, and the existing civil and mass tort caseload in the vicinage should be considered to determine which vicinage a mass tort will be assigned to for centralized management.

Plaintiffs believe that Bergen County is the best suited for this litigation. While Atlantic and Middlesex counties also have mass tort capabilities, Bergen County is closest to all plaintiffs, plaintiffs' counsel, defense counsel, and the defendant HealthPlus Surgery Center was located in Bergen County. The majority of cases filed in the Superior Court are venued in Bergen County, save for a few Complaints filed in Essex County. However, Essex County is closer to Bergen County than the other mass tort centralization options.

For the foregoing reasons, we respectfully request the above captioned cases be classified as Multicounty Litigation centralized

in Bergen County.
