
COURT FILING FEES – CONFORMING AMENDMENTS TO RULE 1:43 TO
REFLECT FLAT RATE SERVICE FEE IN SPECIAL CIVIL PART

The Supreme Court has adopted amendments to the Rule 1:43 to conform to legislation regarding Special Civil Part service fees.

Rule 1:43 (“Filing and Other Fees Established Pursuant to N.J.S.A. 2B:1-7”) is amended to establish a flat rate of \$7.00 for service of process by Court Officer for each defendant. The fee for mileage is eliminated.
