**ORDER TO SHOW CAUSE WITH
TEMPORARY RESTRAINTS PURSUANT
TO RULE 4:52**

THIS MATTER being brought before to the court by O'Connor, Parsons, Lane and Noble, LLC, attorneys for Plaintiffs, the Estate of John Gaudreau and the Estate of Matthew Gaudreau, seeking relief by way of temporary restraints pursuant to R. 4:52, based upon the facts set forth in the Certification of William R. Lane, and the Verified Complaint and letter brief filed herewith;

It is on this *26th* day of *September*, 2024, ORDERED that Salem County and/or the Salem County Prosecutor's Office appear and show cause before the Superior Court at the Salem County Courthouse in , New Jersey at *10:00 A.M* o'clock in the *fore* noon or as soon thereafter as counsel can be heard, on the *8th* day of *oct*, 2024 why an order should not be issued preliminarily enjoining and restraining any state, county and/or local law enforcement agency from:

- A. Producing, distributing and/or disseminating any records relating to the investigation into the deaths of John and Matthew Gaudreau on August 29, 2024;


- B. Releasing any 911-audio recordings, video footage (including any MVR or BWC footage), photographs, investigative reports, or autopsy photos that depict or contain information pertaining to the fatal motor vehicle accident that occurred on August 29, 2024;
- C. Any other relief this Court deems just and proper.

And it is further ORDERED that pending the return date herein, all state, county and/or local law enforcement agencies, Salem County and/or the Salem County Prosecutor's Office are temporarily enjoined and restrained from:

- A. Producing, distributing and/or disseminating any records relating to the investigation into the deaths of John and Matthew Gaudreau on August 29, 2024;
- B. Releasing any 911-audio recordings, video footage (including any MVR or BWC footage), photographs, investigative reports, or autopsy photos that depict or contain information pertaining to the fatal motor vehicle accident that occurred on August 29, 2024;
- C. Any other relief this Court deems just and proper.

And it is further ORDERED that:

A copy of this Order to Show Cause, and all supporting affidavits or certifications and letter memo be served upon the Salem County Prosecutor's Office ^{and} ^{and the New Jersey State Police} or Salem County's counsel by certified mail, overnight courier service, or personal service unless Defendants' counsel acknowledges service.
