Judge Grant,

I have read the Supreme Court Committee on Minority Concerns Report for 2015-2017. I have also read the Committee's recommendations. Recommendation 2017:03 is that there be mandatory continuing legal education on "specified diversity requirements." I do not believe the Supreme Court should accept this recommendation. Adoption of this recommendation is essentially the Supreme Court stating to all attorneys that we attorneys are so diversity ignorant and/or so diversity insensitive that it is imperative to the practice of law that we undergo "diversity training" to address the alleged ignorance and/or insensitivity. I believe that mandate not only would be an insult to all attorneys, but also would perpetuate that unfounded stereotype. RPC 8.4(g) already adequately addresses attorneys inappropriate conduct in this regard.
