Some of these barriers may include lack of transportation, missing work, loss of earnings, and lack of childcare. Many times, victims of domestic and sexual violence face financial burdens after their victimization. With that being said, victims are sometimes using their last dollar to pay for an attorney for their final restraining order or protective order hearing. Having virtual hearings lessens the costs of attorney fees. There are also victims of domestic and sexual violence who may no longer feel safe going into public spaces post COVID-19. Many individuals are still fearing for their health.
