
THAD BURR, ("Burr") hereby certifies and says:

1. I am a First Vice President of MidFirst Bank and Midland Mortgage, now a division of MidFirst Bank. I am fully familiar with the facts set forth in this Certification and make this Second Supplemental Certification on behalf of MidFirst Bank in response to Administrative Order 01-2010, Docket #F-238-11, In the Matter of Residential Mortgage Foreclosure Pleading and Document Irregularities.
2. This certification shall serve to supplement MidFirst Bank's June 1, 2011 and June 28, 2011 Certifications.
3. Pursuant to new court rules in New Jersey, when a Complaint or Certification of Proof of Amount Due is returned by counsel to MidFirst in completed form, Melissa Poage (Poage) or Burr utilizes a checklist to review all of the data contained in the Complaint and/or Certification against MidFirst's business records.
4. The checklist is being revised to expressly state that the person signing the checklist has verified each point based upon a review of business records.
5. Upon confirmation that the Complaint and/or Certification is accurate according to MidFirst's business records, Poage or Burr signs the checklist and returns it to the attorney to complete the certificate of diligent inquiry.

6. Training materials for employees who are being trained to sign certifications is complete and was reviewed by the Court. MidFirst continues to expect training to be completed within the next 30 to 60 days.
7. Pursuant to N.J. Court Rules R.1:4-4(b), I certify that the foregoing statements made by me are true. I am aware that if any of the foregoing statements made by me are willfully false, I am subject to punishment.
