





1. I was never served with a copy of the Summons and Complaint. The letter I received from Chase bank was my first notification of this action.
2. After researching my docket number, F-58885-10, default has not been entered. Indeed, plaintiff has taken no action on this case in years. Thus, this case should have been administratively dismissed under N.J. Court Rule 4:64-8 for failure to prosecute.
3. The plaintiff in this case does not have standing to foreclose.
4. The plaintiff did not properly follow the securitization process and does not possess true ownership of the note.
5. This loan was procured by fraud.


