I Adam Deutsch of full age hereby certify as truthful the following:

1. I am an Associate Attorney with the law firm of Denbeaux & Denbeaux. This law firm represents Defendant in the above captioned case.
2. This certification is made in opposition to Plaintiff's Order to Show Cause and proposed corrective Notice of Intent to Foreclose.

3. Mr. Saracino and Ms. Chacon are currently facing foreclosure, however their case is a contested matter. I have discovered several other clients who have been wrongfully included in the Plaintiff's OSC application.
4. Despite the fact that Plaintiff is aware that this law firm represents Mr. Saracino and Ms. Chacon, Denbeaux & Denbeaux received no correspondence relating to the OSC and application specific to the Mr. Saracino OSC matter. The client brought the paper-work in question to my attention.
5. On November 24, 2010 Plaintiff filed a foreclosure complaint commencing litigation against William Saracino and Monica Chacon. A copy of the complaint is attached hereto as **Exhibit 1**
6. Soon thereafter, on February 16, 2011 Defendant filed a contesting answer to the complaint. A copy of the contesting answer is marked **Exhibit 2**.
7. The parties conducted discovery and each filed motions for summary judgment. The matter settled by way of dismissal prior to return of the Summary Judgment Motions.
8. As recently as August 2012 I appeared personally before Judge Volkert for a case management conference in this case. Plaintiff was represented by its attorney Robert Baily of Zucker Goldberg & Ackerman. A copy of Plaintiff's proposed Case Management Order following that conference is attached hereto as **Exhibit 3**.
9. On April 4, 2012 New Jersey Supreme Court Chief Justice Rabner executed an order permitting Plaintiff to file an Order to Show Cause seeking relief to serve Notices of Intention to Foreclose in open and non-contested foreclosure cases. A copy of the order is hereto attached as **Exhibit 4**.

10. Plaintiff submitted to the Court a list of thousands of homeowners for which relief under the April 4, 2012 Order would be sought. Plaintiff included Defendant William Saracino and Monica Chacon as one of the Uncontested Foreclosures for which relief is being sought under the Order to Show Cause. Mr. Saracino is identified on the 24 page of Plaintiff's Exhibit 19. The document is hereto attached as **Exhibit 5**, bates stamped page 24.
11. Plaintiff's brief to the court seeking relief under the Order to Show Cause is hereto attached as **Exhibit 6**. Plaintiff specifically informed the court in its submission that relief is only being sought for active, pre-judgment uncontested foreclosures.
12. In December 2010 the New Jersey Supreme Court filed an Order to Show Cause directing Plaintiff and other mortgage lenders to establish that sufficient efforts were being made to prevent fraud on the court in foreclosure document submissions. A copy of the Order to Show Cause from 2010 is marked **Exhibit 7**.
13. On February 2, 2012, the New Jersey Supreme Court formally closed the 2010 Order to Show Cause, having been satisfied that the Plaintiff banks were no longer submitting false information to the Courts. A copy of the February 2 order is hereto attached as **Exhibit 8**.
14. In early 2011 Plaintiff Wells Fargo submitted the document marked **Exhibit 9** to the Court in opposition to the 2010 Order to Show Cause.
15. In connection with the 2010 Order to Show Cause, a special master was appointed by the Court to oversee Plaintiff's submissions. A copy of that directive is marked **Exhibit 10**. Defendant submits this document as it is being once again requested that a special master be appointed to oversee obvious errors in Plaintiff's representations.

The within statements are made truthfully. I understand that if any were made willfully false I may be subject to penalty under law.



If you do not file and serve a written answer or motion within 35 days, the Court may enter a judgment against you for the relief plaintiff demands, plus interest and costs of suit. 

FIRST COUNT

1. On 01/05/2007, William C. Saracino and Monica Chacon executed to Wells Fargo Bank, N.A. a Note (hereinafter "Note") securing the sum of \$488000.00, payable on 02/01/2037 with the initial interest rate of 6.3750% per annum.

2. To secure the payment of the Note, William C. Saracino and Monica Chacon, husband and wife, executed to Wells Fargo Bank, N.A., a Mortgage (hereinafter "Mortgage") dated 01/05/2007, and thereby mortgaged to Wells Fargo Bank, N.A. in fee the land hereinafter described (hereinafter "Mortgaged Premises"). - m. to clearly and accurately disclose the "total of payments", using the term, and a descriptive explanation such as "the amount you will have paid when you have made all scheduled payments", and
- n. to disclose that the obligation has a demand feature; and

- o. to disclose the fact that the demand feature disclosures are based on an assumed maturity of one year as provided in Regulation Z Section 226.17(c)(5) [12 C.F.R. 226.17(c)(5)], and
- p. to clearly and accurately disclose in a credit sale, the "total sale price" using the term, and a descriptive explanation (including the amount of any down payment), and
- q. to disclose, in the event that an obligation includes a finance charge computed from time to time by application of a rate to the unpaid principal balance, a statement indicating whether or not a penalty may be imposed
- r. to disclose, in the event an obligation includes a finance charge other than a finance charge computed from time to time by application of a rate to the unpaid principal balance, a statement indicating whether or not the consumer is entitled to a rebate of any finance charge if the obligation is prepaid in full, and
- s. to disclose any dollar or percentage charge that may be imposed before maturity due to a late payment, other than a deferral or extension charge, and
- t. to disclose the fact that the creditor has or will acquire a security interest in the property purchased as a part of the transaction, or in any other property identified by item or type, and
- u. to properly disclose the items required by Section 226.4(d) in order to exclude certain insurance premiums from the finance charge, and
- v. to properly make the disclosure as required by Section 226.4(e) in order to exclude from the finance charge certain fees prescribed by law or certain premiums for insurance in lieu of perfecting a security interest, and
- w. to disclose a statement that the consumer should refer to the appropriate contract document for information about nonpayment, default, the right to accelerate the maturity of the

obligation, and prepayment rebates and penalties; and

x. to disclose, in a residential mortgage transaction, a statement whether or not a subsequent purchaser of the dwelling from the consumer may be permitted to assume the remaining obligation on its original term, and

y. to disclose, in the event that creditor requires the consumer to maintain a deposit as a condition of the specific transaction, a statement that the annual percentage rate does not reflect the effect of the required deposit

WHEREFORE, Defendants demand judgment dismissing the complaint of the Plaintiff together with assessment against the Plaintiff for costs, attorney's fees and such other charges as this honorable court in law and equity may impose

RESERVATION

The Defendants reserve the right to amend and make application for remedies provided by NJ § A. 2A:59-15.2

WHEREFORE, these Defendants demand judgment against the Plaintiff dismissing the complaint together with the assessment against the Plaintiff for costs, attorney's fees and such other charges as this Honorable Court in law and in equity may impose



Such summary actions should be filed with the Clerk of the Superior Court and assigned to each judge upon filing.

It is FURTHER ORDERED that, if approved by the court, any corrected Notice of Intention to Foreclose served pursuant to an order issued as a result of such an action must be accompanied by a letter to the defendant mortgagor and/or parties obligated on the debt setting forth the reasons why the corrected Notice of Intention to Foreclose is being served, the procedure to follow in the event a defendant wishes to object to the Notice of Intention to Foreclose, the individuals to contact with any questions, and that the receipt of the corrected Notice of Intention to Foreclose allows defendant mortgagors and/or parties obligated on the debt 30 days in which to object or to cure the default.

It is FURTHER ORDERED that any Rule 4:64-1(a) or Rule 4:64-2(d) Certification of Diligent Inquiry filed by a plaintiff who has served a corrected Notice of Intention to

Foreclose pursuant to an order issued as a result of such summary action shall list therein with specificity the steps taken to cure the deficient Notice of Intention to Foreclose.

It is FURTHER ORDERED that the Office of Foreclosure is authorized to recommend the entry of final judgment pursuant to Rule 1:34-6 in uncontested actions in which the procedures set forth in this Order have been followed.
