1. I am an attorney at law, licensed to practice in the State of New Jersey, and a partner with the law firm of Reed Smith LLP, counsel for Wells Fargo Bank, N.A. (“Wells Fargo”).
2. In this capacity, I have been responsible for the handling of the Order to Show Cause filed by Wells Fargo pursuant to the New Jersey Supreme Court’s April 4, 2012 Order.
3. I make this Certification in compliance with the Order to Show Cause filed on July 19, 2012 and the Amended Order to Show Cause filed on September 17, 2012.
4. I have personal knowledge of all matters stated herein.
5. I personally oversaw and assisted with the printing, mailing, and tracking of the Supplemental Packages in accordance with the Amended Order to Show Cause entered by the

Honorable Margaret Mary McVeigh, P.J.Ch. on September 17, 2012.

6. On September 13, and 14, 2012, our Princeton, New Jersey office mailed two copies of a Supplemental Package to each Foreclosure Defendant.

7. The Supplemental Package included the Supplemental Letter in the format specified in the Amended Order to Show Cause; a copy of the Amended Order to Show Cause, a copy of the Amended Verified Complaint (without exhibits), and the contact list for Legal Services of New Jersey.

8. The Supplemental Package was served via certified mail, return receipt requested and regular mail at the last known address of the Foreclosure Defendant.

9. Each marital couple residing at the same address was served one copy of the Supplemental Package via certified mail, return receipt requested, and one copy via regular mail.

10. In the event Wells Fargo had been provided an address for the estate of a deceased Foreclosure Defendant, the Supplemental Package was mailed to the address of the estate and/or the executor or administrator.

11. A spreadsheet showing the borrower name, mailing address, certified tracking number is attached as **Exhibit A**.

12. The spreadsheet reflects any Supplemental Packages sent via regular mail returned to our office undelivered.

13. The spreadsheet reflects the results of the certified mail for those Foreclosure Defendants who signed the certified mail green cards.

14. Copies of the signed green cards are attached as **Exhibit B**.

15. In accordance with the Order to Show Cause and the directive of the Honorable Margaret Mary McVeigh, P.J.Ch., publication notice was provided two times in each of four

daily newspapers, Star-Ledger, Bergen Record, The Press of Atlantic City, and the Courier-Post.

16. Notice was published in the Star-Ledger on August 20, 2012 and August 27, 2012.

17. A true and correct copy of the Proof of Publication in the Star-Ledger is attached as **Exhibit C**.

18. Notice was published in the Bergen Record on August 13, 2012 and August 27, 2012.

19. A true and correct copy of the Proof of Publication in the Bergen Record is attached as **Exhibit D**.

20. Notice was published in The Press of Atlantic City on August 20, 2012 and August 27, 2012.




