OBJECTION TO ORDER TO SHOW
CAUSE

Tom and Joann Hansen, potential defendants in a foreclosure case believed to be pending in Morris County, hereby object to the Order To Show Cause and represent as follows:

The Hansens were completely unaware of the pending foreclosure case until they received correspondence from Wells Fargo Bank in response to the Court's Order To Show Cause. That correspondence presumed that they were aware of the foreclosure case and had been served with the foreclosure complaint. For no apparent reason, the correspondence did not contain the docket number for their case. The Hansens were not represented by an attorney at the time of receipt of the correspondence from Wells Fargo and had to locate counsel to represent their interests. The task of finding counsel was complicated and lengthened by the lack of a clear statement on the correspondence from Wells Fargo Bank that they were defendants in a case referenced by a docket number. Presumably Wells Fargo Bank has a docket number for each of the cases that it filed and could inform defendants accordingly.

WHEREFORE, Tom and Joann Hansen request that the Court enter a new Order To Show Cause requiring Wells Fargo Bank to include the docket number of any pending foreclosure in correspondence sent to foreclosure defendants.
