SCHEDULING ORDER

IT IS on this 24th day of February, 2011, **HEREBY ORDERED** that:

1. This schedule shall replace the previous schedules established by the court.
2. Mr. Dauber's response to the filings of the six foreclosure plaintiffs shall be submitted by March 11, 2011. The response shall be filed with the Acting Clerk of the Superior Court of New Jersey, with a courtesy copy being filed directly with the

chambers of Mary C. Jacobson, P.J.Ch., at 210 South Broad Street, Trenton, New Jersey 08650.

3. The replies of the six foreclosure plaintiffs to Mr. Dauber's filing shall be submitted by March 18, 2011, with filing to occur as set forth in paragraph 2.
4. The return date of the Order to Show Cause is adjourned until March 29, 2011, at 2:00 P.M.
5. Mr. Dauber shall provide a copy of this order via facsimile to the attorneys on the attached service list and the order shall be filed in the electronic case jacket of the JEFIS system for foreclosure matters maintained by the Office of Foreclosure in the Superior Court Clerk's Office.
