

V. BARRY CORRIDON, of full age, being duly sworn according to law, upon his oath
deposes and says:

1. I am the Senior Vice President in charge of the Mortgage Servicing Department of Hudson City Savings Bank (the "Bank"). I have been with the Bank since I started my career on August 11, 1970. I have been the Senior Vice President in charge of the Mortgage Servicing Department since 1995. From my personal involvement in this matter and from my review of the Bank's records, I am fully familiar with the facts set forth in this Affidavit. I am authorized to make this Affidavit on behalf of the Bank in response to the Supplemental Administrative

Order dated January 31, 2011 Directing Submission of Information from Residential Mortgage Foreclosure Plaintiffs concerning their Document Execution Practices (the "Supplemental Administrative Order").

2. The Bank engages in the servicing of residential mortgage loans. The Bank services residential mortgage loans it originates, which loans are owned either by the Bank or by its wholly owned subsidiary, Hudson City Preferred Funding Corp., a related real estate investment trust (the "HCSB Loans"). The Bank serviced four hundred sixty (460) HCSB Loans that were in foreclosure in New Jersey in 2010. In a very limited capacity, the Bank acts as a third-party servicer for Investors Savings Bank for two (2) residential mortgage loans that were in foreclosure in New Jersey in 2010.

3. The Bank owns several loans that are serviced by third parties. The names of the servicers, and number of residential mortgage loans that they service and that were in foreclosure in New Jersey in 2010, are as follows:


