
DEAN J. MEYER, being of full age, does hereby certify as follows:

This firm represents Federal Home Loan Mortgage Corporation ("Freddie Mac") in the above matter. Respectfully, Freddie Mac is unable to provide the specific number of active loans its servicers are servicing in the State of New Jersey or the number of those loans that are in default because this information is proprietary and not available to the public.

Nevertheless, in furtherance of your request at a conference on May 12, 2011, in a May 17, 2011 Certification, Freddie Mac did provide Your Honor with a list of each of its servicers that services a substantial number of loans (more than 500) in the State of New Jersey, as of May 4, 2011, that is not already subject to the Matter of Residential Mortgage Pleading and Document Irregularities, Docket No. F-059553-1, Order to Show Cause or the December 20, 2010 Administrative Order 01-2010 and Supplemental Administrative Order 01-2010. Aside from Lehman Brothers Holdings, Inc., which is in bankruptcy and its loans are being serviced by Aurora Loan Services LLC, Freddie Mac has contacted each of the servicers' representatives to inform them about Your Honor's April 25, 2011 Order ("the Order") and Your Honor's request that each submit a certification or affidavit pursuant to the Order.


We respectfully request a 30-day adjournment to closely monitor these servicers and the status of their responses to the Order. Once we receive a response, we will submit it to Your Honor. At this point, none of the servicers have indicated that it does not intend to respond to the Order. If we do learn that a servicer is not going to respond to the Order, we will immediately report that to Your Honor. We also will provide you with an updated report regarding all of these servicers on or before July 22, 2011.

Also, some of the servicers listed above have already responded to the Order because they are sub-servicers for other parties in this action. See Certification of VNB Mortgage Services, Inc. and Certification of Cenlar FSB filed on June 10, 2011 on behalf of Sovereign Bank. We also will notify Your Honor if we determine that any of the other services identified above have already filed a certification/affidavit in response to the Order.
