Dear Judge Barisonek:

I write on behalf of our client U.S. Bank National Association, acting solely in its capacity as trustee for certain residential mortgage-backed securitization ("RMBS") trusts (the "Trustee") in connection with the above-referenced proceeding to follow up on my partner John Lavelle's April 4, 2011 letter to Your Honor (the "April 4 Letter").

As the April 4 Letter explained, Your Honor requested that the Trustee attempt to provide to the Court, by servicer, the number of loans serviced on behalf of "Non-SA Trusts" to enable the Court to understand the overall number of loans in New Jersey that each mortgage loan servicer serviced in 2010 on behalf of RMBS trusts for which U.S. Bank served as trustee.¹ On March 25, 2011, the Trustee contacted all of the mortgage loan servicers that service RMBS loans for trusts for which the Trustee serves as trustee and requested that each servicer respond with a report identifying the number of mortgage loans that it serviced in 2010 for which: (a) U.S. Bank, in its capacity as a trustee of an RMBS trust, was the party for whom the servicer serviced the loan, and (b) the loan was secured by New Jersey residential real property. The Trustee also requested that each loan servicer identify the number of loans that met the above criteria that were the subject of judicial foreclosure actions filed in New Jersey in 2010. Appendix B to the April 4 Letter conveyed information that the Trustee had received from servicers as of that date and stated that if the Trustee received additional information, we would supplement that letter.

¹ The April 4 Letter defined "Non-SA Trusts" as trusts for which the Trustee served as trustee but for which a different entity served as securities administrator
